Under present law, persons with HSAs must pay some "fair market value (FMV)" fee for services provided by employer clinics that offer more than first aid service. This webinar will present the results of a survey conducted by NAWHC's partner Mercer on how employers are addressing the issues involved in determining FMV and in offering worksite health center activities to their employees with HSA plans.

How Worksite Health Centers are Responding to COVID-19 Challenges

In March 2020, the National Association of Worksite Health Centers (NAWHC), conducted a survey of employers, unions and vendors operating onsite and near-site centers to gauge the impact of the COVID-19 virus to their centers. The results are directional, not statistically accurate, but reflect, in general, how employer and union centers are addressing the crisis. Healthcare Worker Exposure Response Registry and Hydroxychloroguine Trial

The Healthcare Worker Exposure Response & Outcomes (HERO) Registry is inviting U.S. healthcare workers (nurses, therapists, physicians, etc.) to share their clinical and life experiences in order to understand the perspectives and problems faced by workers on the COVID-19 pandemic front lines. After creating a profile on the registry, participants can choose to participate in surveys and receive invitations to future clinical trials. The first trial, HERO-HCQ, will be available to select registry participants. The trial will test if hydroxychloroquine (HCQ, brand name Plaquenil®) is effective in preventing coronavirus infections in healthcare workers. Participating sites within PCORnet®, the National Patient-Centered Clinical Research Network will use the registry to recruit 15,000 healthcare workers to participate. The registry will also be used for other clinical trials and research studies that address unmet needs for healthcare workers.

There is no cost to enroll in the HERO Registry, which is completely voluntary, and only takes only a few minutes to join. After joining, registry participants will receive surveys and opportunities to participate in future

studies. Healthcare workers can participate as much or as little as they like. The registry will follow a protocol developed by the Duke Clinical Research Institute and data guidelines to keep healthcare worker information secure.

The HERO research program is funded through a <u>Patient-Centered Outcomes Research Institute</u> Award (Contract Number: COVID-19-2020-001). The program is coordinated by the <u>Duke Clinical Research Institute</u> and leverages <u>PCORnet</u>®, the National Patient-Centered Clinical Research Network..
