ADVOCACY

The "Cadillac Tax" on "high-cost" benefit plans has been repealed. On December 20th, the president signed into law H.R. 1865, the end-of-year appropriations and tax bill, that included a provision to fully repeal the 40 percent excise tax on employer health care coverage, enacted as part of the Affordable Care Act. NAWHC worked with the "Alliance to Fight the 40" – composed of business organizations and other entities - over the past four years in trying to delay and remove this potential cost on employers. Thank you to all who supported this effort.

The Metrics of a Value of Investment (VOI) Analysis for Evaluating the Performance of Your Clinic Operations:

- Who is visiting the clinic? Percent of high-risk population/dependents using clinic
- What services/providers are being utilized? What services are needed or provider access increased?
- How many people are being seen?
- Why are they seen?

Clinical Services:

- Number of annual visits/physicals
- Immunization rate
- Mammograms
- Colonoscopies
- Metabolic Syndrome
- A1C levels and lipid screenings
- Eye/foot exams
- ACE/ARB use

Financial Performance:

- Value of services performed CPT code analysis of clinic vs community costs
- Cost of clinic
- Change in total cost of care medical and pharmacy trends
- Reduction in unnecessary emergency room/urgent care use
- Reduction in absenteeism and need for replacement workers

Satisfaction:


- Satisfaction with providers/quality of care
